BOARD MEETING
MINUTES
March 10, 1982

The regular monthly meeting of the Board of Directors of the Bellwood Public Library was called to order at 8:00 p.m. by President Mrs. Clifford in the library meeting room.

Attendance: Present were Mr. Lyons, Mrs. Sabel, Mr. Riley, Mrs. Meller, and Mrs. Clifford. Mr. Harris, the Head Librarian, was also in attendance. Dr. Fletcher was absent.

Minutes: The minutes of the February 10, 1982, Board meeting were approved as received. A motion was made by Mr. Riley, seconded by Mr. Lyons, to accept and place on file the minutes of the February 10, 1982, Board meeting. The motion passed unanimously.

Review and/or Revision of Agenda: President Mrs. Clifford asked the Board to review and/or revise the Agenda as appropriate. The Agenda was accepted as written by a unanimous agreement.

Mrs. Meller made a motion, seconded by Mr. Riley, to accept Mrs. Will's resignation with regret, and to send her a letter of acceptance. All ayes, unanimously passed.

Mr. Riley presented the staffing quotas, and after discussion, it was decided to continue the discussion at the Administration Committee meeting, to be held March 22, 1982, at 7:00 p.m. in the library meeting room.

<u>Building and Grounds Committee</u>: Mrs. Meller reported that the reference room is finished, and the shelving is installed. The electrical wiring for the microfilm machines is completed. The wiring for the children's room transmitter will be completed next week.

The library received a revised bid from Rex Electric of Bellwood regarding the light switches as follows:

1. Furnish and install six 3 pole toggle switches and one 1 pole toggle switch to control 19 existing lighting circuits.

2. Furnish and install five new 15 amp breakers to replace the old ones. The total bid is \$395.00. A motion was made by Mr. Lyons, seconded by Mr. Riley, to accept the bid of \$395.00 from Rex Electric to complete the existing electrical work. The motion was accepted by a unanimous vote.

The old children's room is cleared out, and can be used for a second meeting room, as needed.

Public Relations and Legislation Committee: No report.

Planning and Development Committee: No report.
