Communications: Mr. Harris received a letter from Mr. John M. Sullivan, Village of Bellwood attorney, regarding the 1983-84 Appropriation Ordinance and Levy.

Mr. Harris received a letter from Molly McGee, Proviso Township Community Worker, University of Illinois Cooperative Extension Service, asking if the Bellwood Library would like to co-sponsor this program with the University of Illinois Cooperative Extension Service. The presentations would be September 21 through October 26, 1983, from 7:00 to 9:00 p.m. The Extension is most interested in reaching singles, the young marrieds, those mid-way in life, and folks planning retirement, as well as seniors. The subject matter includes "Update of Social Security Benefits", "New Savings Investment Alternatives," "Understanding the new I.R.S. laws," "Is Retirement Coming Sooner Than Anticipated?", "Plan for Better Living," "Are you Ready Should you Lose Your Spouse?" The Bellwood Library Board of Directors accepted the Extension's proposed program series, and to co-sponsor this financial security program, and approved to absorb expenses. A full page coverage of the Extension's program is to be published in the Bellwood News Letter at a cost of \$150. Approved by a unanimous agreement.
