As the Bellwood Public Library continues to navigate through this unprecedented time, in our ongoing commitment to protect our community and limit the spread of the COVID-19 virus during the duration of the Governor's Disaster Declaration, the Board of Trustees will conduct its meeting remotely as authorized by the Governor's Executive Order 2020-07, and as extended by Executive Order 2020-39 issued on May 29, 2020 and the Attorney General's Guidance to Public Bodies during the COVID-19 Pandemic. The Board President, having determined that an in-person meeting is not practical or prudent given the Governor's new Disaster Declaration issued on May 29, 2020 (Executive Order No. 2020-38), no Board members will be physically present for the meeting but will instead be participating in the meeting remotely via an online virtual meeting platform. **TEMPORARY PUBLIC COMMENT RULES
FOR REMOTE BOARD MEETINGS
DURING GOVERNOR'S DISASTER DECLARATION RELATED TO COVID-19 PANDEMIC**

1. All members of the public may submit public comments either comments either in the chat option of the Zoom virtual meeting or in advance of and during the meetings via email to the Library Director at crumpa@bellwoodlibrary.org.
2. Public comments will be limited to 3,000 characters each (equivalent to approximately 500 words).
3. All Public Comments received either in the chat option of the Zoom virtual meeting or prior to and up to adjournment of the Board meeting will be read aloud in the order in which they were received by the Library Director during the public comment portions of the meeting as designated on the Agenda. Profanity or obscene words contained in any Public Comments will not be read aloud.
